- Highlights of the 2022-2023 school year
 - Completed legal action with former teacher via settlement.
 - Working with SCSBC to develop SOGI policy.
 - Renovated spaces to be able to keep all students on campus
 - Moved admin wing to front of building.
 - Purchasing committee active to secure building sale and arrange financing through multiple sources.
 - Seeking funding through Christian based institutions that offer better rates than commercial institutions.
 - Brought EA wages in-line with SCSBC Compensation Grid

7. Building Committee Report (Brad Malfair)

- Deal is in place to purchase half the Cranbrook Alliance Church building and adjacent property.
- The boundary line will be the south wall of the foyer.
- Phase one of construction will plan to complete and pay for the purchase of said property.
- Phase two will plan to build a two-storey addition on the grassy area south of the office block.
- Phase three will plan to build a new gymnasium and renovate the existing gym into other useable space.
- A capital campaign will be initiated once the subdivision is complete..
- An animation of the new spaces was presented showing the outside and inside views of the new additions.

8. Principal's Report (Wendy Zurrin)

- Enrollment is at 263 students
- We will have our first graduating class in 2024.
- The hockey academy brought 15 students/ players to the school. Likely program will expand as it becomes more known.
- Mexico missions trip was a huge success and great experience for the 27 students and chaperones.

9. Treasurer's Report (Tyler Jorgensen & Tina Hochart

- KCA financials were audited as required by law by a third party(BDO) and found to be sound.
- Tyler explained differences in income and expenses as compared to 2022. Examples were missions trip to Mexico this year, enrollment up as well as grants.
- More students equals more expenses but there is a net profit of \$185K.
- Tyler shared a plan for paying a future mortgage; there is up to 30 months of payments available based on financing arrangements.
- Overall finances are in good standing. Copies of the financial report available for review.
